OR CELL PHONES TO INFINITY NEW CHANNELS AND COMMERCIALS).

DIRECTV PERSONALLY DID A CABLE BOX TO PROVIDE FOR NEW CHANNELS
SHOWS MOVIES AND COMMERCIALS ON THE TELEVISION BY DOWNLOADING
COPYING OR SCREAMING ONTO THE NEW CABLE BOX THROUGH APPLICATIONS
FOR TELEVISION CHANNELS TO GO TO INFINITY.

THE NEW CHANNELS WOULD PROVIDE STATIONS SHOWS AND COMMERCIALS
ON ALL THE NEW ADDED CHANNELS TO INFINITY BY DOWNLOADING COPYING
OR SCREAMING NEW CHANNELS SHOWS MOVIES AND COMMERCIALS ON ADDED
CHANNELS TO INFINITY. DIRECTV PERSONALLY WENT TO WASHINGTON DC.
