ARE FULLY RESPONDABLE FOR ANY AND ALL THE LISTING OF REAL ESTATE PROPERTY

dear gentlemen

this letter is to inform and advise you of my
request for a full investigation as to EBAY AND EBAY SELLER on written offers BUY IT NOW
and AUCTION AND BIDS of my real estate properties as to the following

EBAY AND EBAY SELLER ARE FULLY RESPONDABLE FOR ANY AND ALL THE LISTING OF REAL
ESTATE PROPERTY

i went on ebay real estate property to purchase a buy it now at \$199.00 real estate properties
these real estate properties were not a AUCTION NOR A BID
theses real estate properties were a BUY IT NOW AT \$199.00
i personally made written offers to purchase each one of these real estate properties
i personally purchased four (4) real estate properties paying by withdrawing money from my
bank account at metro bank
into a business bank account homes dirt cheap was the owner of the chase bank account
along with making two (2) offers on two other properties i personally made an offer in writing
to the seller for two (2)
other properties state i can purchase the property

the seller at ebay turned around and listed the other two (2) real estate properties right after i personally made an offer to purchase these two (2) real estate properties but i had to pay off the other four properties first there was a processing fees for each real estate properties for \$600.00 for typing up the DEED's (title and ownership of the property) as you can see in the listing of the real estate property were was no estimated closing statements required by law and regulations at the NMLS and Ameritrain companies i personally felt that the processing fees were double amount on the charges for typing up a deed the ebay seller stated i did not pay for the real estate properties that i did not own the real estate properties at all

i personally contacted the ebay and ebay seller i wanted to know if the four(4) real estates properties were rented out because the day i purchased the real estate properties was the day i was the owner and that the rental income on this real estate properties belong to me along with the rental income could pay in cash the processing fees for the typing of the deeds

after i purchased the four (4) real estate properties ebay and ebay seller RE-LISTED MY REAL ESTATE PROPERTIES FOR SALE ON EBAY (unknown if property was re-sold) i personally feel that this was GRAND LACARY the michigan chief of police stated internet fraud and theft and to file a notice of complaint with EBAY the estimated real estate values on these real estate properties were from 60 thousand dollars up to 120 thousand dollars along with rented income estimated at 1400.00 to 1600.00 hundred dollars a month from MAY 21, May 23, JUNE 08 and JUNE 10 of 2016 when i brought these real estate properties

i personally purchased the four (4) real estate properties in CASH on a BUY IT NOW \$199.00 MAY 21, 2016 M, May 23, 2016 JUNE 08, 2016 and JUNE 10, 2016 all rental income funds and money belong to me as of the date purchased

i personally sent out rental letters to the tenants to pay there rent to me along with

the bank information to do a direct deposit into my bank account after purchasing these four (4) real estate properties

ebay and ebay seller personally did not state there were delinquent real estate property taxes due and payable

on these four (4) real estate properties Weeks later i found out that there were TAX SALES on all four

real estate properties but did not get the rental income to make payments arrangements to start clearing

up the delinquent taxes that were due and payable from the YEAR of 2012 to present

ebay and ebay seller personally were fully responsible for the LISTING OF THE REAL ESTATE PROPERTIES

i personally went to the MICHIGAN GOVERNOR with a letter to postponement of the tax sale due to the

facts that i just paid for the real estate properties CASH

I PERSONALLY DID NOT HAVE TITLE OR THE DEEDS TO THE REAL ESTATE PROPERTIES AS OF YET TO PAY THE TAXES TO PAY THE BILLS FOR WATER TRASH AND ELECTRIC

I PERSONALLY DID NOT HAVE THE DEEDS AND TITLE TO COLLECT THE RENTAL INCOME FROM THE TENANTS

because the escrow did not close at the time

I PERSONALLY DID NOT HAVE TITLE OR DEEDS TO THE REAL ESTATE PROPERTIES TO GET A MORTGAGE LOAN PERSONAL LOAN AND HOME EQUITY LINE OF CREDIT ON THE PROPERTIES

i personally sent out letters to michigan utilities company electric company trash company and gas company to see who had been paying on these bills

it was verify if it was an owner or tenant, because if these bills were being paid that

may have showed that there were tenants and the owner was collecting the rental income

i personally am claiming robbery and fraud from the dates when i paid cash for these real estate

properties

44 acres of vacant land in florida as a BUY IT NOW

also i personally made a offer in writing on 44 acres of vacant land (private island) in florida with the

real estate agent on EBAY AND EBAY SELLER

44 acres of vacant land in florida as a BUY IT NOW \$795.00

after my real estate offer in writing was sent to the owner of the property

the owner accepted my offer

i personally made that real estate property offer in writing that was accepted

i was to pay \$400.00 then two weeks later pay another \$400.00 dollars

someone contacted the ebay seller stated they were interest in buying the

44 acres of vacant land in florida

the real estate agent ignored my offer in writing and accepted

to purchase and ignored my accepted offer to buy

ebay and ebay seller personally RE-LISTED MY REAL ESTATE PROPERTY AS A BUY IT NOW AND CHANGED IT TO A AUCTION AND BID

the auction and bid started at \$300.00

i personally did a bid price of up to \$320.00 for the auction and bid sale

doing the auction and bid IN ONE SECOND THE AUCTION AND BID AMOUNT CHANGES FROM \$320.00 to THE BID

AMOUNT OF \$325.00

this i believe was internet fraud and theft

estimated property value is \$1.5 million dollars

IN ONE SECOND THE AUCTION AND BID AMOUNT CHANGES BY \$5,00 dollars i personally am claiming internet fraud

i personally filed notice of complaints with EBAY AND EBAY SELLERS but have not heard of any response

to my complaints filed and emailed to EBAY AND EBAY SELLERS

also i personally feel that someone is PROTECTING EBAY too

this is not a BUY IT NOW personal item nor is it a AUCTION AND BID personal item

THESE BUY IT NOW WAS FOR REAL ESTATE PROPERTIES

i personally have sent my complaints to MICHIGAN POLICE DEPARTMENT AND THE UNITED STATES ATTORNEY GENERAL OFFICE along with sending the notice of complaints to MICHIGAN GOVERNOR AND FLORIDA GOVERNOR

i personally am claiming fraud and robbery
i personally would like to press charges and arrest

after reviewing the evidence you will agree with me that i purchased the real estates properties in cash (see enclosed proof and evidence) this is a federal matter not just a state matter they personally broke federal laws
